Returned units must be in working condition when received at the Honeywell Processing Center. Free one years' service will not apply for non-working units.

End customer must submit the **Service as Value Add Form** from your local Honeywell sales rep.

Standard lead times apply to orders for devices.

Honeywell has the right to change, modify, or cancel the promotion at any time.

Account must be current and in good standing to participate.

Standard terms and conditions of your distribution agreement apply.

Product must be purchased from an authorized Honeywell Distributor in Europe.
